Pre-Departure Preparation: In-person and virtual

Operational Concerns:

Structured Interaction:

Reflection & Analysis:

Journaling/Field Notes: Daily logging of observations, emotional responses, and cultural interactions.

Midterm Assessment: Applying theoretical frameworks of intercultural communication to current experiences.

Final Deliverables & Synthesis:

Cultural Portfolio/Journal: Compiled, reflective entries.

Final Project/Case Study: An ethnographic study or presentation analyzing the experience, comparing it to course readings, and outlining future implications for personal/professional growth.

Learning Objectives:

Cultural Competence: Understanding cultural nuances and developing empathy.

Personal Growth: Increased adaptability, resilience, and self-awareness.

Analytical Skills: Moving from observation to deeper understanding of social, economic, or environmental challenges.

Assessment Criteria:

Participation & Professionalism (40%): Active engagement in all scheduled activities.

Reflective Journaling (40%): Depth of analysis and introspection.

Final Project (20%): Synthesis of experience and academic research.
