- Improve Your Technical Skills


The growth in online enrollments has outpaced the overall growth of higher education in multiple years (3.7 percent increase), as reported in annual reports. According to Federal data, 6,932,074 students enrolled in distance education courses at degree-granting postsecondary institutions in the fall of 2018.³

DEFINING ONLINE COURSE MODALITIES

Online instructional methods at Claflin University can be broadly categorized as follows⁴:

- Online courses - those held entirely online.
- Hybrid courses combine online learning with face-to-face meetings.
- Online Enhancement - An online component to regular classroom instruction enhanced by Internet access and Learning Management System (LMS-Moodle).

Claflin University offers classes over two 8-week semesters in the fall and spring semesters. Intensive courses of 8 weeks are offered to students to make things easier for them. This allows them to concentrate on just two or three classes at once if possible. This scheduling plan has been proven to help students stay on track and graduate on time.



HERE ARE THE STEPS TO GET YOU STARTED

A Guide to Successful Online Learning

These tips have been compiled by the Office of Online Education to help you become a successful online learner:

- Self-motivation, self-discipline, and assertiveness are essential. In an online class, you are more likely to be responsible for keeping up with your studies.
- An online course works in exactly the same way as a face-to-face course, it is neither easier nor takes less time or energy.
- Ensure that you log in at least twice or three times a week. Effective time management is essential. Make better use of your time by planning ahead.
- Since you will interact almost exclusively through written communication in an online course, you should be comfortable with electronic communication and capable of effectively expressing yourself in writing.
- You should be familiar with the use of technology, the Internet and email, as well as how to download, upload and save files.
- You should be well acquainted with your instructors and the best way to contact them. Please contact your instructor, with whichever method he or she specifies, if you experience difficulty.
- You should always communicate with your instructor via your Claflin University email.

Rules of netiquette

Etiquette refers to a code of behavior in society, and netiquette refers to good behavior online. Netiquette rules and guidelines for online courses don't exist officially; however, the following items constitute a basic list of the expectations for netiquette during online learning:

- It is important to read emails carefully to ensure that you understand what they are saying.
- It is important that you read and re-read responses carefully before sending them. It is important to proofread for incorrect grammar, spelling, and punctuation to ensure the reader does not become confused.
- You need to know who you are talking to. Make sure that the person(s) with whom you communicate is the one(s) to whom your message should be sent.
- Include a relevant part of the original message in your reply, or cite the original message.
- Whenever you ask a question, be specific.
- If you wish to receive a response, please include your name at the end of your message, as well as contact information.
- You should use uppercase and lowercase appropriately when typing. It seems rude to use ALL CAPS since it resembles shouting.

Technological Requirements

We have established minimum requirements for the hardware and software needed to ensure the proper operation of Claflin University online courses. Students need a Claflin University username and password to access Moodle and other tools and services provided by the university. For security reasons, student passwords expire every 90 days. As part of an effort to address the concern of Cyber Security, students will be required to change their password every 90 days. Every 90 days, passwords must be changed, but it is advised to change them even more often (e.g. every 60 days). The password change will affect systems like email, Moodle, MyClaflin and access to Library databases ⁶.

MOODLE: HOW TO ACCESS COURSES IN MOODLE

Claflin University uses Moodle as its learning management system for all of its online courses. At Claflin University, each student has their own username and password for internal applications, such as Moodle and MyClaflin. Students enrolled in online programs at Claflin University can obtain a picture ID from Claflin's enrollment services office. In online courses, instructors may require proctored exams and universities may request identification verification.

Here are a few recommendations for maintaining a strong password

Passwords should not be shared with anyone for any reason. This includes family members, friends, classmates, faculty, and staff. Claflin University or its representatives will never call you or send you an email asking for your password.

If your password is compromised, change it immediately

It is imperative that you change your password as soon as possible if you suspect that it may have been compromised. After you have reset your password, please contact the office of information technology.

Don't write down or store your password in an insecure manner

It is generally advisable not to write down your password. It is always a good idea to store passwords in a secure place and destroy them when no longer needed.


Get direct access to Moodle

Assessments are often carried out in professional settings while students are supervised. The syllabus of your course will clearly state if Respondus Lockdown Browser and Respondus Monitor will be used for identity verification.

Students can easily take an online test using LockDown Browser once their instructors have instructed them to download, install, and use the application. Higher education's leading remote proctoring solution is Respondus Monitor®. It enables students to take online tests from the comfort of their homes while maintaining their integrity during the process.

ACADEMIC ADVISING & REGISTRATION

INTRODUCTION

The world of academic advising can be an adventurous journey, and your dedication and commitment are greatly appreciated. Thank you for embarking on the path toward proficiency and high-quality practices in Proactive and Appreciative approaches to advising.

Academic advisors are partners in the online student's educational journey. Advising for online students is centered on building rapport and trust within the advising relationship with students, creating a degree plan that maps out the academic path through graduation, monitoring student performance to identify academic challenges, fulfilling degree requirements, assisting with course registration, and supporting students by connecting them to other Claflin services. For a holistic advising experience, coaching is incorporated into the advising services to help students establish and achieve their academic and career goals.

Dropping Classes

100% Refund Period/Drop

To qualify for a 100% refund of tuition and per-credit-hour fees, a drop must be approved prior to the 100% refund deadline published for each semester. There are specific dates for certain courses that are 100% refundable; please consult course listings for details.

Withdrawal from the University

When ALL courses that a student is enrolled in during a semester are terminated, it is considered withdrawal. Students who are taking only one course and drop that course would not be considered a drop. In other words, this is a withdrawal.

Attendance Policy

To qualify for financial aid, a student must attend classes. Student participation in course activities helps auditors confirm a student's attendance. It is recommended that students engage in online activities like discussion boards, reading materials, assessments and quizzes every two to three days.

It is expected you will spend approximately 8-12 hours per week, per course, which includes at least 5 hours of work online per week, including participation in online discussion forums.
